Exhibitor, trainer or agent must sign entry blank or class sheet. If not signed, the first entrance into the ring as an exhibitor shall be construed as acceptance of this and all other show rules. The show will not be responsible for any accident or theft occurring at this show. EXHIBITING HORSES WITHOUT A VALID WHOA CARD IS SUBJECT TO SUSPENSION FROM ALL WHOA SHOWS.
